The following resolution was offered by Ethan Ashley and seconded by Nolan Marshall, Jr.

A resolution aimed at supporting the New Orleans Youth Master Plan and encouraging schools within the District to utilize the resources available through the Youth Master Plan.

**WHEREAS**, the New Orleans Youth Master Plan is facilitated by the New Orleans Children and Youth Planning Board (CYPB), the New Orleans Youth Alliance (NOYA), and the Mayor's Office of Youth and Families (OYF) with co-direction and co-authorship by New Orleans youth, including the Youth Advisory Board of CYPB, the Mayor's Youth Advisory Council (MYAC), and NOYA Youth Leadership Fellows; and

**WHEREAS**, the New Orleans Youth Master Plan is a comprehensive 10 year multi-sector roadmap for creating and sustaining a positive, youth-development focused and results-oriented New Orleans that works for all of our young people, developed by young people, parents, educators, community leaders and stakeholders; and

**WHEREAS**, the New Orleans Youth Master Plan contains a set of data tools which may be used to effectuate data-driven decisions to benefit the City's children and youth; and

**WHEREAS**, the New Orleans Youth Master Plan presents an opportunity for our community to be intentional about the future of the youth of our City and build pathways for that potential to become a reality by improving outcomes for children and youth, from birth to age 24, across Orleans Parish.

**NOW, THEREFORE, BE IT RESOLVED**, that the Orleans Parish School Board supports the vision of the New Orleans Youth Master Plan and encourages school leaders across the district to utilize the resources developed and offered in collaboration with the New Orleans Youth Master Plan.
